As a former State Assemblywoman representing Central New Jersey and a current Somerset County Freeholder, respectively, we were troubled to read a recent report about Rutgers University's decision to mandate that incoming freshmen pay a \$175 fee, in part, to take a course on the impact of so-called microaggressions.¹

Frankly, aside from this new mandate being political correctness run amok, the associated cost required of students and parents to take this course – in the wake annual tuition increases over the last three years totaling around \$500 – is ridiculous. $^{2\ 3}$
