#### NEW EVIDENCE SURFACES CONNECTING MAYOR LANKEY, EDISON DPW DIRECTOR, AND SKYWAY STRATEGIES WITH "PEOPLE FOR PROGRESS"; PURCHASE OF STAMPS

Edison, NJ (May 28, 2019) - Edison Council Vice President, Ajay Patil, expressed frustration with the Edison Township Council's Committee of the Whole over the Committee's resistance to issuing subpoenas to Mayor Thomas Lankey, DPW Director Anthony Russomano, a corporate representative from Skyway Strategies, and a corporate representative from Jaffee Communications.

The purported purpose of the committee was to investigate the disgraceful Make Edison Great Again fliers and the political action committee "People for Progress", an entity that surfaced during the fall 2017 Mayoral election.

The mailers in 2017 were the first in a series of controversial fliers, most recently mailers from the Edison Democrats 2019 ("Real Democrats") campaign that were criticized by the ACLU and NAACP. A federal complaint against Edison Democrats 2019, a slate including Councilmembers Lombardi, Sendelsky, Diehl, Joshi, and Gomez, is pending.

Mr. Patil requested that the four witnesses be placed under oath to provide testimony regarding the racist Make Edison Great Again fliers and their role with "People for Progress." While Mayor Lankey issued a statement at the Committee's initial meeting on May 14, he was not placed under oath and he was not asked questions by the committee.

"In an effort to get the committee back on track for its initial purpose, on May 24, 2019, I requested the attorney for the committee to issue subpoenas for these individuals," said Mr. Patil. "I was advised by the attorney for the Committee, through an email, that I do not have the authority to request that these be subpoenaed and that the authority to do so rests with Council President Gomez. He has not advised me whether he intends to honor my request," said Mr. Patil.

Mr. Patil is pointing to an email from Mr. Russomanno that connects Mr. Russomanno with Skyway Strategies and People for Progress.

On September 19, 2017, Anthony Russomanno forwarded an email with the subject line "Final Version: Negative Republican Mailer." See Exhibit A. The email includes an email chain between Mr. Russomanno and Skyway Strategies describing a negative mailer against Keith Hahn. In the email Skyway Strategies states to Mr. Russomanno "This version includes your request to label Hahn as a cop who's such a dunce that he cannot pass a promotions test." It also asks for Mr. Russomanno's "written approval(s) to move ahead."

A mailer meeting these specifications was later released by the group known as People for Progress. See Exhibit B

A second email from Mr. Russomano on October 10, 2017, with the subject line "Edison Dems Dear Neighbor Letter" included an image of a flier that Skyway Strategies recommended "easily copied at Office Max or Staples." From the email it appears that Skyway strategies is recommending that these fliers be mailed with stamps much like the racist flyer that was sent out as opposed to using a traditional mail house. <u>See</u> Exhibit C.

It has been revealed that Mr. Lankey's campaign paid for a large number of stamps in the fall of 2017. While the committee of the whole received testimony that Shariq Ahmad, the Chairman of the Edison Democratic Organization purchased \$3,920.00 in stamps, the Committee did not inquire as to who paid for the stamps. An ELEC report filed by Mr. Lankey on November 27, 2017 shows that the Lankey campaign paid \$3,920.00 on November 1, 2017 for postage. See Exhibit D.

"Unfortunately, the committee has become a parlor game, with fingers pointing at all. Instead of a committee searching for the truth, it has become a political vehicle for the Lankey Team, the Column A Democrats," said Richard Brescher, a current Board of Education Member and council candidate.

Mr. Brescher stated that he provided committee members with evidence that Skyway Strategies was an entity related to Jaffee Communications, a Township vendor that is paid to act as the Mayor's spokesperson. "I told Council member Diehl back in 2018 that Skyway and Jaffee communication were related entities. It baffles me why they would not call them for testimony," said Mr. Brescher.

Mr. Hahn, in his testimony to the Committee of the Whole provided details regarding the funding of People for Progress and the associated mailers. According to Mr. Hahn, the PAC was funded by supporters of Mayor Lankey, specifically PegPAC. See Exhibit E.

In summary, there is now evidence that 1. Mr. Lankey's campaign paid for stamps in November 2017; 2. That the Political Action Committee known as People for Progress sent mailers meeting the specifications created by Mr. Russomanno and Skyway Strategies; 3. Skyway Strategies and Jaffee communications are related entities; and 4. Evidence that People for Progress was funded through contributions from individuals supporting Team Lankey.






