OFFICE OF THE MAYOR Executive Order No. 2020-01

WHEREAS, the spread of COVID-19 within New Jersey constitutes an imminent public health hazard that threatens and presently endangers the health, safety, and welfare of the residents; and

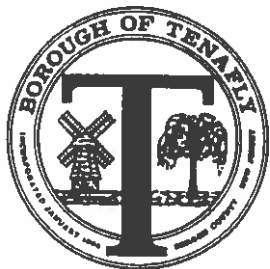
WHEREAS, on March 9, 2020, the Governor of the State of New Jersey declared the concurrent invocation of both a State of Emergency pursuant to N.J.S.A. App.A.:9-33 *et seq.* and a Public Health Emergency as contemplated by N.J.S.A. 26:13-1 *et seq.*, which invoked the authority and powers contemplated by N.J.S.A. 26:13-3, the Emergency Health Powers Act, and remains in effect; and

WHEREAS, all of the terms of Executive Order No. 2020-01 and 2020-01A, which declared a State of Emergency in Bergen County by County Executive James Tedesco and March 12, 2020 and March 13, 2020, respectively and established mandates to combat COVID-19, remain in effect; and

WHEREAS, on March 13, 2020, President Donald Trump issued a proclamation declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) Outbreak; and

NOW THEREFORE, I, Mark Zinna, as Mayor of the Borough of Tenafly, do hereby order and direct that:

- 1) With safety in mind, effective immediately, and until further notice, Borough Hall and all borough facilities are open only for employees. This includes the Tenafly Recycling Center. No members of the public, or non-employees are permitted within borough buildings until further notice unless under emergency circumstances.
- 2) All public parks and sports fields in Tenafly, whether on Borough property or Board of Education property are closed.
- 3) All private gyms, sports clubs and facilities, dance establishments, personal training facilities and yoga facilities are closed.
- 4) Restaurants are strongly recommended to suspend in-restaurant dining services and move to take-out and delivery service only.
- 5) The police department is witnessing groups of youth congregating closely together. This is not in compliance with social distancing protocols. Please advise your children to practice safe social distancing behavior.
