

## **Family of Hasani Best and Advocates Demand Release of Videos of Police Homicide**Hasani Best is City's Second Police Homicide of Man Who Closed Door on Police within One Year

(Asbury Park – September 10, 2020) Surviving relatives and advocates are calling for the release of audio and video¹ collected by the Attorney General's Office in the investigation of the police murder of Mr. Hasani Best by Asbury Park Police. Additionally, the signers below are demanding to know the identity of the shooter(s) as well as where and when the Attorney General is planning to convene a grand jury to present evidence. Lastly, the undersigned demand to know if any audio or video is missing because of failure to wear a body camera, failure to turn

it on, or any other reason.

The family is completely distraught and does not deserve to endure anymore anxiety over the loss of their loved one Mr. Hasani Best. To date, family members have received little to no information regarding the final moments of Mr. Hasani's life. Furthermore, in what appears to be an extremely disturbing likeness, Mr. Hasani's murder at the hands of the Asbury Park Police, is the second such killing of an individual who had closed a door on police. On July 23, 2019 police were called to an Asbury Park address. The resident James Manzo closed the door and said he did not need to talk to police. Less than an hour later police entered the apartment and shot him to death.

Enough time has passed to release the videos and other requested information. In a recent case the Attorney General's Office released video of the murder of Maurice Gordon by State Trooper Wetzel, 17 days after Mr. Gordons killing. Today marks 20 days since Mr. Hasani Best was murdered. Additionally, the family should be afforded Victim's Rights meaning they should

receive regular updates about the investigation and prosecution of any officers should that take place as per the New Jersey Crime Victims Bill of Rights<sup>2</sup>.

The undersigned are asking that the information requested be released to the family immediately so that they may view it in private and then release the information the next day to the public.
