- c) Any bills from Calcagni and Kanefsky to the City of Linden from January 2020- present.
- d) Emails between (to and or from) any key city personnel* and the domain ck-litigation.com That were sent or received between January 2020- present and include: Any attachment (Pdf, word or other attachment) and/or Key words (any or all of the following): "Scutari" "Prosecutor" "Bryant."
