#### **INSIDERNJ POLICY MAKERS 2024**

Campaign politics overshadowed the budget season this year, as Tammy Murphy supplanted Phil Murphy in the statewide public eye. In the end, Phil Murphy's budget quietly survived, while Tammy Murphy's U.S. Senate candidacy infamously died.

This list usually prioritizes the Trenton-based brainiacs who try to find a way to try to spin out of control spending into an argument for how the public benefits. This year, however, the corruption meltdown of U.S. Senator Bob Menendez created a federal office opening, and the ensuing debate immersed New Jersey's political intelligentsia in campaigns and elections law.

You'll recall, of course, that U.S. Rep. Andy Kim (D-3) – long the beneficiary of ballot bracketing as an establishment Democrat – decided (in his own best interest, but that's politics, folks) in the most morally indignant fashion, that "the party line" punishes the democratic aspirations of most New Jerseyans. So even as Governor Murphy primed the establishment to accept and crown his wife as the next U.S. Senator from New Jersey to supplant the fetid political corpse of Menendez, Kim launched his insurrection.

The Murphys tacitly relied on the strength of the governor's position as the chief overseer of the budget, and the appetites of key county leaders, hopeful for a budget beneficial to their self-interests. The Murphys' simple, unspoken calculation required county party to support Tammy Murphy's senate

candidacy by bracketing her as the organization choice on the June ballot, in exchange for goodies (that's an old Joe DiVincenzo term) in the budget.

Kim had other plans. From the Associated Press on Feb. 26th, 2024: "New Jersey's primary ballot design unconstitutionally favors candidates who have the support of political party leaders and should be scrapped, U.S. Rep. Andy Kim, who's locked in a primary contest for U.S. Senate against the state's first lady Tammy Murphy, said in a federal lawsuit filed Monday. The suit seeks to upend New Jersey's unique primary ballot system in which candidates backed by political party leaders appear grouped together on the ballot, with challengers in separate columns, and takes aim at a system widely considered to be a crucial advantage in primary contests."

In the end, a judge sided with Kim, granting the preliminary injunction to eliminate the so-called county line, thereby essentially removing the ballot design teeth from the mouths of 19 of the 21 county party chairs in New Jersey. Tammy Murphy pulled the plug on her campaign, but the budget season endured.

Last month, on time and with little fanfare, Governor Murphy signed the record-biggest New Jersey budget in state history, totaling \$56 billion, spending \$2.1 billion more than it takes in, while fully funding the state's pension and school funding.

#### From The New Jersey Monitor:

"We can go back and forth and talk about what's

in the budget, and I think all of us have agreed this budget is not perfect, but there's a lot of good in here," said Assemblywoman Eliana Pintor Marin (D-Essex), the chamber's budget chair.

"The bill cleared the Assembly in a 55-22 vote. Assembly members Don Guardian (R-Atlantic), Claire Swift (R-Atlantic), and Sean Kean (R-Monmouth) crossed party lines to back the bill. The Senate approved the bill in a 27-13 vote. Sens. Vince Polistina (R-Atlantic) and Bob Singer (R-Ocean) were the only Republicans to vote in its favor."

Along the way, the usual policymakers in both parties had their say, pro and con, inspired and astonished, admired (well, at least respected) and barely tarnished. The state's political chattering classes were still talking about Andy Kim, now facing a credible Republican challenger in businessman Curtis Bashaw. At their splendid Middletown home, the Murphys held a scheduled fundraiser for a debate rattled and party-embattled President Joe Biden amid muttered speculation about a cabinet position landing for the First Lady. But beyond a fast-developing, fascinating national election, New Jerseyans continued to contemplate the longer-range implications of the line change. As for the Murphys, with Joe Biden gone now as a presidential prospect, to paraphrase Humphrey Bogart in Casablanca, they'll always have Harris.

### ANDY KIM

U.S. CONGRESSMAN, DISTRICT 3, DEMOCRATIC NOMINEE FOR U.S. SENATE



When U.S. District Judge Zahid Quraishi (see below) eliminated the so-called county line in the Democratic Primary and undercut New Jersey bosses' influence, he gave the most significant political – and policy – win of the season to the congressman, a 2024 candidate for the United States Senate. Why isn't Quraishi number one on this list and Kim number 2? The judge wouldn't have had that case on his desk without Kim filing the lawsuit, and the congressman demonstrated significant momentum already early in the primary process.

### ZAHID N. QURAISHI

Scrapping bracketing in favor of block ballot construction, the judge in his decision made clear his understanding of the magnitude of his decision. "The integrity of the democratic process for a primary election is at stake and the remedy Plaintiffs are seeking is extraordinary," wrote Quraishi. "Mandatory injunctive relief is reserved only for the most unusual cases. Plaintiffs' burden on this Motion is therefore particularly heavy. Nevertheless, the Court finds, based on this record, that Plaintiffs have met their burden and that this is the rare instance when mandatory relief is warranted."

### MATT PLATKIN

#### ATTORNEY GENERAL OF NEW JERSEY



When Platkin sent Judge Zahid N. Quraishi a letter ahead of the judge's decision, notifying him that his office would not defend the three state statutes that prescribe how New Jersey designs its primary ballots, the attorney general signaled his willingness to play a vocal role in the developing policy debate regarding the efficacy of New Jersey's primary ballot system. "The challenged statutes are unconstitutional," Platkin wrote, "therefore the state has no interest in defending the county line." His letter came as sources anticipated Quraishi imminently ruling against the line in Kim et al. v. Hanlon, a lawsuit filed by Kim, questioning the justice of New Jersey's county party line ballot system. Platkin's letter carried the added weight of an upper echelon member of the Murphy Administration opposing the establishment process in place, even as Governor Phil Murphy's wife, First Lady Tammy Murphy, ran against Kim in the Democratic Primary for the United States Senate.

### TAMMY MURPHY

#### FIRST LADY, THE STATE OF NEW JERSEY



Okay, so maybe she's an unwitting occupant of this list, in the sense that she did not contribute a policy perspective to the debate, other than to vaguely support the status quo. But her candidacy in the aftermath of Menendez's gold bar nosedive showed the extent to which the party apparatus had drifted from a hardnosed ground game in touch with real voters. That's a significant contribution.

Veteran progressive lawmaker Bonnie Watson Coleman this year proved vital in gaining information from the U.S. Department of Housing and Urban Development (HUD) regarding the disparate impact of eviction on Black renters, women, and children - three classes protected by the Fair Housing Act. Each year, the congresswoman noted, 2.9 million children are affected by an eviction, or one child every ten seconds. Eviction rates during childhood are higher than at any other age. While Black Americans only make up 18.6% of all renters in the United States, over half (51.1%) of those affected by eviction are Black. Additionally,

those who have been evicted for any reason regularly find it harder to secure safe housing in the future. "Despite the incredible strides our nation has made since the Fair Housing Act was signed into law in 1968," read the letter sent by Watson-Coleman and her colleagues, "there are still grave injustices – particularly concerning equitable access to affordable, safe, and stable housing." According to the Sentencing Project, as many as one in three adults in the United States — up to 100 million Americans — have interacted with the criminal justice system, a disproportionate amount of whom are people of color. A criminal record creates barriers to jobs, higher education opportunities, and public benefits – including those supplied by HUD. We know what it takes to win in difficult situations.






### STEVEN PERSKIE

#### POLICY ADVISER TO MAYOR MARTY SMALL, CITY OF ATLANTIC CITY



Elected to the New Jersey General Assembly in 1971 at age 26, and re-elected in 1973 and 1975, Democrat Perskie was the primary advocate and sponsor for the introduction of casino gaming in Atlantic City and was responsible for drafting what would become the New Jersey Casino Control Act. Perskie beat Republican Frederick Perone in the 1977 state senate race. In 1981, Perskie was again challenged in the general election by former Democratic Senator Joe McGahn, who ran as a Republican. Perskie won reelection with 29,151 votes, defeating McGahn, who received 28,149. Perskie was appointed an Atlantic County Superior Court Judge in 1982. In 1989, he resigned from the bench to manage James Florio's successful gubernatorial campaign. He served as Florio's Chief of Staff from 1989 to 1990. He was appointed Chairman of the New Jersey Casino Control Commission in 1990, where he served until 1994. During his tenure, Perskie oversaw a comprehensive restructuring of the agency.

### SEAN MAROTTA

#### ATTORNEY

Now affiliated with the interests of the Middlesex County Democratic Organization, Marotta joined the Kim v. Hanlon case as a friend of the court, arguing the just principles behind New Jersey's line system challenged by Kim.






